Jack Curtin, age 73 of 406 W. Zimmerman St. Forest died at 1:20 a.m. Monday June 27, 2005 at his residence, the home where he was born on Oct. 26, 1931 to Lloyd V. and Mildred (Wilcox) Curtin, who preceded him in death. He married Ann L. McKinley in Kenton on Dec. 4, 1955 and she survives. He was a member & past president of the Forest Lions Club and was a recipient of the Melvin Jones award, a member of Senate Lodge #378 F&AM, Forest. A member of Scottish Rite Valley of Toledo. He was a member of Heritage Christian Union Church.

He was a gifted storyteller who dedicated his life to serving God & country & was devoted to his family. Funeral Service will be held Thurs. June 30, 2005 at 11:00 a.m. in the Heritage Christian Union Church with Pastor Ken Gray & Pastor Mark Bishop.
