Jimmie R. Eaves age 59 of Upper Sandusky died at his residence surrounded by his family on Friday Feb. 3, 2012 at 6:50 p.m. He was born on March 16, 1952 in Lake Charles; LA to John David Eaves and Elberta (Fusilier) Eaves.
